On the above date and time, I, Lieutenant [REDACTED], was assigned to Zone 1. At 1859 hours, I contacted Deportation Officer [REDACTED] to inform [REDACTED] about Inmate [REDACTED], who had an Ice detainer and was scheduled to be bailed out. As my call went to voicemail, I then reached out to the Ice Duty Line and spoke with an officer, providing details about Inmate [REDACTED]. The officer assured me of a callback and shortly after, I was informed that ICE was approximately 20 minutes away, coinciding with the ongoing bail process.

Then, I notified [REDACTED] of the situation, and [REDACTED] instructed me to handle the bail, as I would normally will. The bail clerk arrived at 1901, and Inmate [REDACTED] posted bail at 1930 hours, leaving the jail at 1931 hours. The first ICE Officer [REDACTED] arrived at 1938 hours, while [REDACTED] arrived at 1942 hours, missing Inmate [REDACTED]. Officer [REDACTED] expressed dissatisfaction that Inmate [REDACTED] was not detained, mentioning that [REDACTED] should not have been released and suggesting that I should have slowed down the processes. I explained to [REDACTED] that once an inmate posts bail, I am no longer able to detain them.

It is worth mentioning that Officer [REDACTED] frustration arose from Inmate [REDACTED] release from custody, leading to unprofessional behavior where [REDACTED] raised [REDACTED] voice in front of my staff stating, "You know you let [REDACTED] go". [REDACTED] came in to the back officer in a aggrieve manner, insisting on detaining Inmate [REDACTED] due to [REDACTED] criminal charges, I reiterated to [REDACTED] that after an inmate post bail I'm am not allowed to detain [REDACTED]. After our interaction, Officer [REDACTED] left the facility. EOR

Officer [REDACTED] began speaking to Lt. [REDACTED] in an aggressive manner. I [REDACTED] along with the Inmate felt uncomfortable in the manner in which [REDACTED] was conducting [REDACTED] Officer [REDACTED] frustration arose from Inmate [REDACTED] release from custody, leading to unprofessional behavior where [REDACTED] raised [REDACTED] voice in front of Officer's and Inmate's, "You know you let [REDACTED] go".
