The first ICE Officer arrived at 1938 hours, while arrived at 1942 hours, missing Inmate Officer expressed dissatisfaction that Inmate was not detained, mentioning that should not have been released and suggesting that I should have slowed down the processes. I explained to that once an inmate posts bail, I am no longer able to detain them.	
	It is worth mentioning that Officer frustration arose from Inmate voice in front of my staff raising, "You know you let go". It came in to the back officer in a aggrieve manner, insisting on detaining Inmate due to criminal charges, I reiterated to that after an inmate post bail I'm am not allowed to detain After our interaction, Officer left the facility.
